EOIs will be evaluated based on the bidder's eligibility, relevant experience, technical approach, and financial capability. Shortlisted bidders may be invited for further discussions or for participation in a detailed Request for Proposal (RFP) process.

Eligibility Criteria

The bidder

- Must be a **registered legal entity in India** and submit valid documentation including PAN, GSTN, and Certificate of Incorporation (ROC).
- Must have been **operational for a minimum of three years** in sectors such as telecom, broadcast, meteorology, IT infrastructure, or media.
- Must have **successfully completed at least three similar projects** for Government departments, PSUs, Government undertakings, or Autonomous Bodies involving tower erection, antenna systems, or IT infrastructure installations.
- Must possess all **relevant approvals and licenses**, such as WPC, SACFA, and DoT clearances, as applicable.

General Terms & Conditions

- The **lessee shall bear all costs** related to installation, insurance, operation, and maintenance of the equipment.
