4. Background

HIGH SPEED DATA COMMUNICATION (HSDC) SERVICES

STPI has been the pioneer as Data Communication Service Provider in India since 1993. In 1993, STPI-Hyderabad provided nx64 Kbps data communication connectivity to STP units through Intelsat F3 Standard Earth Station (ES) as the First International Gateway. STPI started providing last mile connectivity (point-to-point) to customer premises through owned RF/Microwave. STPI was then the first organisation to provide point-to-multipoint Microwave Radio network for Internet services in India. STP units within 30 km radius of the ES are connected through line-of-sight point-to-multipoint TDMA microwave links.

STPI also holds the Unified license for Category-A Internet Service Provider (ISP) with ALL INDIA as the service area. In fact, STPI is the first commercial Internet service provider of India and the first to offer Digital Private Line through multiple-access radio network. STPI's National service delivery and management infrastructure includes 63 independent gateways through NOCs at STPI centers.

Last Mile Connectivity (Local Loop)

In the early 90s, the IT industry was growing and the demand for bandwidth was huge. While international bandwidth was available, there was a shortfall in the last-mile connectivity. To address the last mile connectivity challenges, STPI provided Microwave network catering to the immediate needs of the customers. This network was further strengthened by the addition of Pointto-Point radio networks enabling the delivery of a 2048Kbps or more bandwidth over the last mile.

STPI uses the latest software tools to design the microwave link and the same is tested in-house before implementation. Over a period of time, STPI microwave network has evolved to be one of the biggest microwave networks in use for data communication and has now become a true multivendor network.

During the post-millennium era, private operators participated in this segment and delivery of services through copper/fiber based last mile connectivity has become a reality. STPI has established a collaboration with all major service providers to service last mile over copper and fiber. With the last mile on copper / fiber there is considerable improvements in quality of service such as reduced delay, multiple redundancy options etc. The last mile service providers have designed the last mile in such a manner that the fiber is extended very near to the customer premises. This ensures that the last mile connectivity to the customer premises is only a few meters. The fiber switches of all the major service providers are located at STPI NOC, which reduces the provisioning time and increases the efficiency in case of troubleshooting.

5. Purpose of EOI

STPI-HYD Directorate invites proposal(s) from **the Last Mile Local loop service provides** (vendor) through Expression of Interest (EOI) for **Empanelment of Last Mile Local loop service provides for providing Last mile (Local loop / Long Distance) Services** for the purpose of provisioning, installation, maintenance and monitoring of Lastmile service over Optical Fiber Cable / Copper Medium / Microwave for a period of **5 years** for STPI Hyderabad, Visakhapatnam, Tirupati, Vijayawada, Kakinada and Warangal.

The shortlisted/selected Last Mile Local loop service provides through this EOI process will become the Empanelment Members of respective center/s of STPI-HYD Directorate to provide Last Mile Local loop service to STPI-Softlink customers from STPI-center/PoP/NOCs at



Hyderabad, Visakhapatnam, Tirupati, Vijayawada, Kakinada and Warangal initially for a period of 3 years, which may be extended for further period of 2 years with mutual consent.

6. Scope of Work

STPI Hyderabad Directorate (STPI-HYD) provides premium Internet Services to IT / ITeS companies & Educational Institutions across the state of Andhra Pradesh and Telangana through its Centers, PoPs at Hyderabad, Visakhapatnam, Tirupati, Vijayawada, Kakinada and Warangal.


STPI-HYD identified 3Gbps (approx.) of Last mile bandwidth requirement for its Softlink customers for the next three years.

In this juncture, STPI-HYD intends to have a panel of Service providers to provide Last mile services through the empanelment process. The empanelment process involves technical evaluation for selection of the Panel of Agencies to undertake provisioning, installation & maintenance and monitoring of Last mile.

The **Detailed Scope**, **Deliverables** and **Service levels** for the Empaneled Last mile service provider is mentioned below in **14.1** of this document. The Panel of Service providers empaneled/created, shall be valid for a period of 3 Years from the date of notification of the empanelment, which may be extended for further period of 2 year with mutual consent.

8. Eligibility Criteria

ii	The Vendor should have experience of successful delivery of similar works (Provisioning, Installation, Maintenance and Monitoring of Last mile Connectivity) in the last 3 years as of 31.03.2023 with Last Mile bandwidth - multiples of E1, at least for 10 customers for each Location in Hyderabad and/or sub centers (Visakhapatnam, Tirupati, Vijayawada, Kakinada and Warangal.) where feasibility is claimed. iii	The Vendor should have valid licenses (ISP/OSP/NLD/other valid licenses) for providing last mile services in the claimed locations.	Documentary evidence should be provided.
iv.	The Vendor should have a minimum annual average revenue of Rs. 20 Lakhs from "Similar Work" only, in the last two financial years (2021-22 & 2022-23) for which the vendor's accounts have been audited. vi. The vendor should: -

a) not be insolvent, in receivership, bankrupt or being wound up, not have its affairs administered by a court or a judicial officer, not have its business activities suspended and must not be the subject of legal proceedings for any of the foregoing reasons.

b) The organization should not have been debarred and/ or blacklisted by any organization of GoI/Central PSU/State Gov. Entities as on the proposal submission date. c) not have, and their directors and officers do not have, been convicted of any criminal offense related to their professional conduct or the making of false statements or misrepresentations their as to qualifications to enter into a procurement contract within three years preceding the commencement procurement of the process, or not have been otherwise disqualified pursuant to debarment proceedings

Self-certification by the authorized signatory duly signed and stamped on the company letterhead as per the format in Form –5.

9. Instruction to Last Mile Local loop Service Providers(Vendors):

STPI invites vendors to submit their proposals in accordance with the conditions and manner prescribed in this Expression of Interest (EoI) document:

- a. The vendor should ensure that the Lastmile circuits provisioning does not violate regulations such laid by Govt. of India/ TRAI/WPC etc in respect of such links /networks. Vendor shall seek necessary permission from respective authority. Vendor will be responsible for making all the payments towards the Last mile licensing charges, Right-of-Way charges, etc., to respective government bodies/ agencies.
- b. The vendor should be able to provide Last mile service for at least one or (all) STPI location specified in **Annexure-I**.
- c. The vendors are requested to fill the location feasibility details in **Annexure-II**. Vendor(s) should provide details of their existing OFC terminations /copper/ wireless in the locations required by STPI-HYD as mentioned in the **Annexure II** (Network feasibility).
- d. Vendors are advised to study this EoI document thoroughly. Submission of Technical Empanelment proposal should be deemed to have been done after careful study and examination of this document with full understanding of its implications.



- e. The vendor should be able to provide Last mile service for at least one STPI location from the list specified in Annexure-I. The existing fiber/copper roll out / connectivity diagram and network details to be enclosed. Documentary evidence should be provided.
- f. The vendors are requested to fill the location and POP wise network feasibility details in **Annexure-II**.
- g. The vendor shall furnish as part of his proposal, documents establishing the conformity of Bid Documents to all services, which the vendor proposes to supply under the Services, by clearly indicating 'complied' or 'not complied'. No ambiguity in compliance should be there in the proposals. The documentary evidence of the services in conformity to the Proposal document may be in the form of literature, drawings and data. It may comprise of:
 - i A clause-by-clause compliance on the Technical Specifications, Terms & Conditions demonstrating substantial responsiveness to the Technical Specifications, Terms & Conditions.
 - ii In case of deviations, a statement of the deviations and exception to the provision of the Technical Specifications, terms & conditions shall be given by the vendor.
 - iii In case there is no deviation, "NIL" deviation statement shall be given. A bid without clause-by-clause compliance of the Technical Specifications, shall not be considered.
 - iv Further, wherever specifications indicate a specific parameter to be met, vendor shall indicate the actual value of the parameter.
- h. If any requested document is not submitted by the vendor at the time of submission of proposal/evaluation in support of the above clauses, the evaluation of proposals will be based on available documents and non submission will be treated as non-availability of documents.

9.1 <u>Completeness of the EoI Response</u>

Vendors are advised to study all instructions, forms, terms, requirements, and other information in the EoI documents carefully. Submission of EoI shall be deemed to have been done after careful study and examination of the EoI document with a full understanding of its implications. The response to this EoI should be complete in all respects. Failure to furnish all information required by the EoI documents or submission



of a proposal not substantially responsive to the EoI documents in every respect will be at the vendor's risk and may result in the rejection of their proposal.

9.2 Proposal Preparation Cost

The vendor is responsible for all costs incurred in connection with participation in this process, including, but not limited to, costs incurred in the conduct of informative and other diligence activities, participation in meetings/discussions/presentations, preparation of the proposal, in providing any additional information required by STPI to facilitate the evaluation process. STPI will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the EoI process. All materials submitted by the vendor shall become the property of the STPI and may be returned at its sole discretion.

9.3 Evaluation Process

The vendor must possess the technical know-how and the financial capabilities that would be required to successfully provide the services sought by STPI. The vendor's proposal must be complete in all respect and conform to all the requirements, terms and conditions and specifications as stipulated in the EoI document. The evaluation process of the EoI proposed to be adopted by STPI is indicated under this clause.

The purpose of this clause is only to provide the vendor with an idea of the evaluation process that STPI may adopt. However, STPI reserves the right to modify the evaluation process at any time during the EoI Evaluation process, without assigning any reason, whatsoever, and without any requirement of intimating the vendor of any such change.

STPI shall appoint an EoI Evaluation Committee (EEC) to scrutinize and evaluate proposals received. The EEC will examine the proposals to determine whether they are complete, in response and whether the proposal format conforms to the EoI requirements. STPI may waive any informality or nonconformity in an EoI that does not constitute a material deviation.

9.4 Rights to terminate the Process

STPI may terminate the EoI process at any time and without assigning any reason. STPI makes no commitments, express or implied, that this process will result in a business transaction with anyone. This EoI does not constitute an offer by the department.

9.5 Rights to Accept/Reject any or all Proposals

STPI reserves the right to accept or reject any proposal and to annul the EoI process and reject all EoIs at any time prior to award of contract, without thereby incurring any liability to the affected vendor or vendors or any obligation to inform the affected vendor or vendors of the grounds for STPI's action.

9.6 Failure to agree with the Terms & Conditions of the EoI

Failure of the vendor to agree with the Terms & Conditions of the EoI shall constitute sufficient grounds for the annulment of selection.



9.7 **Indemnity**

The successful vendor shall indemnify, protect, and save STPI against all claims, losses, costs, damages, expenses, action suits and other proceedings, resulting from infringement of any patent, trademarks, copyrights etc. or such other statutory infringements in respect to services rendered by vendor.

9.8 VALIDITY OF PROPOSALS:

Proposals shall remain valid for a minimum period of 180 days from last date of submission. STPI-HYD may solicit the vendors' consent to an extension of bid validity (but without the modification in Proposals).

9.9 RIGHT TO ACCEPT PROPOSAL

STPI-HYD reserves the right to accept or reject any proposal, and to annul the Empanelment process and reject all proposals, at any time prior to award of contract without assigning any reasons whatsoever and without thereby incurring any liability to the affected vendor or vendors on the grounds of the Purchaser's action.

9.10 DISQUALIFICATIONS

STPI-HYD may at its sole discretion and at any time during the evaluation of Proposal, disqualify any vendor; Non-compliance of any one of following shall result in outright rejection of the bid.

- a. Submitted the Proposal documents after the deadline for submission of proposal.
- b. Made misleading or false representations in the forms, statements and attachments submitted in proof of the eligibility requirements.
- c. Submitted the proposal document without taking into account the amendments / clarifications provided.
- d. Submitted a proposal that is not accompanied by required documentation (mentioned in **Eligibility clause 8**) or is non-responsive
- e. Failed to provide clarifications related thereto, when sought.
- f. Declared ineligible by the Government of India/State/UT Government for corrupt and fraudulent practices or blacklisted.
- g. Failure of the successful technically qualified Last Mile Service provider to comply with the requirement of Acceptance to Letter of Empanelment shall be sufficient ground for the annulment of the acceptance of the proposal.
- h. Any effort by a vendor to modify his proposal or influence, from the time of opening the proposal till the time, the contract is awarded; may result in the rejection of the proposal.
- i. Not meeting the minimum qualification criteria



- j. Any other reason which is not in accordance with EoI.
- k. Any interlineations, erasures or over writings shall not be valid.
- No commercial information whatsoever shall be provided in this empanelment process.
 Failure to do so may disqualify the bid.

10. General Terms and Conditions

- i. Lodgment of an EoI is evidence of an vendors's consent to comply with the terms and conditions of the EoI and subsequent bidding process. If any vendor fails to comply with any of the terms, its EoI may be summarily rejected.
- ii. Willful misrepresentation of any fact within the EoI will lead to the disqualification of the vendor without prejudice to other actions that STPI may take. All the submissions, including any accompanying documents, will become the property of STPI. The Vendors shall be deemed to license and grant all rights to STPI, to reproduce the whole or something any portion of their proposal document for the purpose of evaluation and to disclose the contents of submission for regulatory and legal requirements.
- iii. Vendors must inform STPI immediately in writing of any material change to the information contained in the EoI application, including any substantial change in their ownership or their financial or technical capacity. Copies of relevant documents must be submitted with their information. For shortlisted Vendors, this requirement applies until a contract is awarded as a result of the subsequent bidding process.
- iv. STPI reserves the right to modify and amend any of the stipulated conditions/criteria given in this EoI, depending upon project priorities vis-à-vis urgent commitments. STPI also reserves the right to accept/reject an EoI, to cancel/abort the process and/or reject all EoIs/Bids at any time prior to award of empanelment, without thereby incurring any liability to the affected vendors on the grounds of such action taken by the STPI.
- v. Any default by the vendors in respect of EoI terms & conditions will lead to rejection of its EoI.
- vi. Any attempt by a vendor to bring pressure towards STPI's decision-making process, such vendor shall be disqualified for participation in the EoI and those vendors may be liable to be debarred from bidding for STPI tenders/RFP/EoI in future for a period of three years.
 - vii. The decision of STPI arrived during the various stages of the evaluation of the EoIs is final & binding on all vendors. Any representation towards these shall not be entertained by STPI.
 - viii. Printed/written conditions mentioned in the EoI proposals submitted by vendors will not be binding on STPI.
 - ix. Upon verification, evaluation/assessment, if in case any information furnished by



- the vendor is found to be false/incorrect, their total proposal shall be summarily rejected and no correspondence on the same shall be entertained.
- x. STPI will not be responsible for any misinterpretation or wrong assumption by the vendor while responding to this tender.

11. Technical Evaluation

Evaluation of the proposals shall be carried out to determine whether the vendor is competent enough and whether the vendor's proposal qualifies for the requirements set forth herein.

13. NOTIFICATION OF AWARD/EMPANELMENT:

- **a)** The vendors who qualify in the technical evaluation are eligible for receiving the Empanelment Letter from STPI-Hyderabad for delivering Last Mile Local Loop service to STPI-Soft link customers from STPI centers/PoPs.
- b) The successful vendors shall give their acceptance within 7 days of issue of the Empanelment Letter.

The shortlisted/selected Vendors center-wise through this EOI process will become the Empanelment Members of respective STPI-centers to provide Last Mile Local loop service to STPI-Softlink customers from STPI-center/PoPs at Hyderabad, Visakhapatnam, Tirupati, Vijayawada, Kakinada and Warangal initially for a period of 3 years, which may be extended for further period of 2 years with mutual consent.

14. Post- Empanelment Process

14.1 Detailed Scope, Deliverables and Service levels of Work after Empanelment

The Technically qualified Empaneled Last Mile Service providers have to provision Last mile (Local Loop) service and maintain & monitor the same provided on the Optic Fiber (OFC)/ Copper / Microwave circuits for STPI Hyderabad and other centers/Locations as mentioned in Annexure-I of this document.

These Guidelines define the broad areas of work, which Last mile service providers shall perform for a period of 3 Years from the date of issue of empanelment order which may be extended for further period for 2 years with mutual consent.

A. Feasibility Stage:

- i. Feasibility study of the Last mile services as and when demand arises by STPI-H; as per the format mentioned in Form-3 'Techno-Commercial Quote' of this document..
- ii. This feasibility report shall be submitted to STPI within 1 week from the date of Requisition.
- iii. Failure to submit the feasibility and commercial study report within the above mentioned period, the Empaneled Service provider will be treated as non-responsive for this requirement.
- iv. Feasibility report should be valid for a period of 60 days from the date of submission of the report.



B. Implementation Stage:

The vendor has to implement & ensure a reliable physical connectivity on either Optic fiber or Copper cable media between premise of STPI Centre and its Customer as committed by the Empaneled Service provider in the Last mile feasibility Report.

If Optic fiber or Copper cable media is not feasible to reach the destination, Empaneled Service provider may provision the link through wireless upon mutual consent with STPI. All licensing requirement for the wireless connectivity should be borne by Empaneled Service provider.

All the Optic Fiber/Copper cables routed between STPI-Locations to Customer End should be routed through Underground only and not through Overhead.

All permission and licensing from local authority should be obtained and borne by the empaneled Service provider.

This activity has to be completed by the Empaneled Service provider within 3-4 weeks from the date of issue of Work Order by STPI-H for a particular link; along with submission of the Last mile commissioning report by empaneled Service provider in the format of <u>Form-4</u> 'Last Mile Commissioning Report' of this document.

During Implementation stage, any delay beyond 3-4 weeks from the date of issue of Work Order, Penalty at the rate of 0.5% per week on the total work order value will be levied subject to maximum of 4% which shall be deducted in the first quarterly bill. If breach or delay is beyond acceptable time, then STPI at its discretion shall terminate the contract and avail the service from other Empaneled Service providers. The non performing Service provider may not be considered for future requirements.

C. Operation & Maintenance Stage:

i.The Operations & Maintenance of Last mile connectivity shall be carried out by the ii. Respective Empaneled Service providers with prior consultation with STPI-HYD.

iii.The Operations & Management of Last mile connectivity shall include but not limited to the following:

- a. 24/7 Help desk support to STPI.
- b. Escalation Matrix chart
- c. Submission of Performance Reports to STPI
- d. Dedicated Account Manager for respective STPI centers.

iv.Ad-hoc reports required by Regulatory Authorities (i.e. TRAI/WPC etc) as per requirement shall also be generated. The Empaneled Service provider is expected to furnish necessary information about the service being offered which may be necessary for STPI to meet the regulatory requirements.

v. Service support shall meet the applicable SLA parameters as mentioned in this EoI.



vi. The successful vendor shall not further sub-contract whole or part of this assignment to any third party without the prior written permission of the STPI. In case, the necessity arises to sub-contract, in such instances STPI shall be kept informed about such arrangements and the Service provider empanelled shall be the single point of contact for STPI.

D. PLACEMENT OF LOCAL LOOP ORDERS ON EMPANELED SERVICE PROVIDER

- a) Based on the requirement of Last Mile local loop, respective centers will issue The feasibility & Commercial offers/quote request to all the respective empaneled service providers of that particular STPI-Center.
- b) The empaneled Service provider needs to submit the commercials (total cost- inclusive of taxes, no additional charges shall be levied by the vendor) for last mile connectivity between sites A-B, as per **Form-3**.
- c) The vendors needs to submit the commercial offer through e-mail / sealed cover within 1 week whenever such request is made.
- d) Successful contractor will be determined among the commercial quotes received from the empaneled Service providers, based on the best feasibility and commercials.
- e) The Contract order will be placed on Successful Service provider-as per the choice of STPI-Hyderabad.
- f) The Contract order will be issued by STPI Hyderabad and payment will be released to Successful Service provider against Contract order and after successful Implementation of Last Mile local Loop between A-B.
- g) Each contract shall be valid for the minimum period of one year and auto renewed till termination of local loop service.
- h) Minimum contract period of one year shall not be applicable in case of upgradation /Down gradation and disconnection/price revision.
- i) Timeline for all upgradations shall not be beyond 1-2 weeks, down gradations shall be within a week.
- j) In Exception cases, if STPI-Softlink customer (B end) serves one month notice (within one year of implementation) for disconnection same will be applicable to local loop Service provider and billing will be made accordingly.



E. PAYMENT TERMS:

STPI Hyderabad shall make payments towards the Last mile services to the Empanelled Service provider in Indian Rupees and payment terms shall be as follows:

- (i) The SLA reports for the local loop service availed by respective centers shall be submitted by the Empaneled Service provider within 15 days after each quarterly billing cycle.
- (ii) Payment shall be made within 30 days from the date of receiving the invoice.
- (iii) The invoice has to be raised by the Empaneled Service provider on successful delivery of Services on a Quarterly basis.
- (iv) The payment will be made quarterly in arrears for the service provided by the empaneled Service provider
- (v) The payment will be made by the STPI Hyderabad, for the services rendered to sub Centers.

F. CONFIDENTIALITY:

Information relating to the clarification and comparison of the Proposals shall not be disclosed to any vendors or any other persons not officially concerned with such process until the empanelment process is over. The undue use by any vendor of confidential information related to the process may result in rejection of its Proposal. During the execution of the project except with the prior written consent of STPI, the Empaneled Service provider and its personnel shall not at any time communicate to any person or entity any confidential information acquired in the course of the Contract.

G. GENERAL TERMS & CONDITIONS:

1. TERMINATION OF EMPANELMENT WITH STPI

The empaneled Service provider's contract with STPI-H shall be terminated in following two ways:

- I. The term of Empanelment period expires. (On account of the expiry of the period of empanelment).
- II. Termination of Empanelment by STPI-H due to non-performance during the contract period:
 - a) Performance is below committed SLAs for four continuous quarters.
 - b) If SLA is breached below 90% for two quarters in the year, then the penalty of 10% of annual charges will be deducted and the vendor will be debarred.



c) Non-Non-adherence to the timelines of the last mile (Long distance / Last mile) service deliveries / commitment for three or more circuits.

III Disconnection served by:

- a) Customer-only contract for that particular Last mile service terminates, Empanelment with STPI continues.
- b) STPI- Contract for all Last mile services terminates, Empanelment with STPI terminates.

2. Blacklisting

Company/Firm blacklisted by Govt. /Autonomous Body/PSU/Corporate organization are not eligible to Bid. If at any stage of bidding process or during the contract, such information comes to knowledge of STPI, the STPI-HYD shall have right to reject the bid and terminate the contract, as the case may be, without any compensation to the vendor.

3. RESOLUTION OF DISPUTES

If any dispute arises between parties, then there would be two ways for resolution of the dispute under the Contract:

(i) Amicable Settlement

Performance of the Services is governed by the terms and conditions of the Empanelment contract. However at times dispute may arise on any interpretation of any term or condition of Empanelment process including the Scope of Work, the clauses of payments etc. In such a situation either party may send a written notice of dispute to the other party. The party receiving the notice of dispute will consider the Notice and respond to it in writing within 30 days after receipt of notice. If the party fails to respond within 30 days, or the dispute cannot be amicably settled within 60 days following the response of that party, then below Clause shall become applicable.

(ii) ARBITRATION

All disputes or difference whatsoever arising between the parties out of or relating to the construction, meaning and operation or effect of the purchase order/work order or the breach thereof such dispute or difference shall be referred to Arbitration. The venue of arbitration shall be Hyderabad, India. The Arbitration and Conciliation Act 1996 and all its amendments, the rules there under and any statutory modification or re-enactment's thereof, shall apply to the arbitration proceedings

All documents and communications between the parties shall be in English. However, the expenses incurred by each party in connection with the preparation, presentation shall be borne by the party itself.

4. LEGAL JURISDICTION:

All legal disputes between the parties shall be subject to the jurisdiction of the Courts situated in Hyderabad, India only.



5. CO-LOCATION FACILITY:

Empanelled Service provider will be provided STPI's co-location facility to house their last mile equipment i.e. MUX etc., if the empanelled Service provider network is dedicated for only STPI operations. In case Service provider propose to use the same network for their other business operations, Service provider will be liable to pay the charges of co-location facility to STPI as per standard co-location rack space tariff of STPI as be applicable to other third party telecom service providers time to time.

6. Force Majeure: if at any time, during the continuance of this contract, the performance in whole or in part by either party of any obligations under this contract shall be prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restriction, strikes, lockouts or act of God provided notice of happenings, of any such eventuality is given by the either party to the other within 21 days from the date of occurrence thereof, neither party shall be resumed as soon as practicable after such event may come to an end or cease to exist, and the decision of the STPI as to whether the deliveries have been so resumed or not shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days either party may, at its option terminate the contract

H. Performance Guarantee / Performance Security

Interest free Performance Guarantee/ Performance Security of **3%** is applicable for each contract whose order value is above 5 lakhs p.a. by Seller to the Buyer.

Performance Guarantee/ Performance Security must be submitted within 15 days of award of contract order for providing Last Mile connectivity between intended STPI location/center to STPI Softlink customer.

Performance Guarantee/ Performance Security for an amount of 3% of the order value is to be furnished in the form of an Account payee Demand Draft, Fixed Deposit Receipt from a Commercial Bank or Bank Guarantee from a Commercial bank in an acceptable form by the successful bidder.

Duration of Performance Guarantee/ Performance Security is till the validity of each contract order issued by STPI-HYD Directorate to the vendor (last mile local loop service provider) for providing Last Mile connectivity between intended STPI location/center to STPI Softlink customer.

Performance security should be in favor of Beneficiary, wherever it is applicable:

Forfeiture of Performance Security: Performance Security/e-PBG submitted by the successful Last Mile Local Loop Service Provider to STPI shall be forfeited If the Vendor fails / delays in performance of any of the obligations, under the EoI/Contract / violates any of the provisions of the EoI/Contract / commits breach of any of the terms and conditions of the EoI/Contract, in such case STPI may, without prejudice to any other right of action / remedy it may have, forfeit Performance



Security of the Contractor.

Return of Performance Security / Performance Guarantee after the expiry of validity of each contract order.

14.2 Technical Requirement (Post Empanelment)

A. Establishing Connectivity between STPI(center, Pops) and Empanelled Member:

Post Empanelment, the Empanelled Member should establish Fiber/Copper connectivity to STPI center/Pops. The Empanelled Service provider shall carryout the site survey to determine exact measurements of work required. Empanelled Service provider shall provide cables, jacks, patch panels, and all other materials needed to complete this requirement.

Service provider will open, close, and return opened or used pathways and spaces to original form.

Empanelled Service provider shall provide certified test results of new cable installed which includes cable loss results. Empanelled Service provider shall provide a copy of network diagram showing interconnect points, backup links, and details of peering with Lastmile Exchanges to respective STPI-location, PoPs.

Installation and setup requirements:

- 1. Empanelled Service provider should request for the pre support requirement at respective STPI-HYD, location, where last mile services has to be established.
- 2. Empanelled Member is requested to install necessary equipment's at STPI premises within a month, at no extra cost to STPI.
- 3. Empanelled Service provider equipment's should support IPV6.

Compliance with standards

All the works shall be in accordance with guidelines specified by the EIA/TIA Building Telecommunications Wiring Standards, the BICSI Telecommunications Distribution Methods Manuals (TDM), and manufacturer/Service provider installation guidelines. These documents and standards form the basis for the installation, testing, and acceptance of the structured communications cable system for Lastmile.

B. Physical interface requirements

Vendor has to provide the full duplex Interfaces like E1/ Fast Ethernet / Gigabit Ethernet / OFC etc, as per the requirement at the respective STPI and its sub centers / customer locations.

C. Emergency Power Backup:

Empanelled Service providers shall ensure high availability of the local loops by providing the MUX with adequate UPS capacity as and when it is required.



D. Equipment Association:

Associated equipment like Modems/ Media Converters to Fast Ethernet or any such interface requirement /necessary accessories for commissioning the link shall be provided by the Empanelled Service provider only. The Empanelled Service provider shall include any other hardware/ software item required for installing and commissioning the system, at no extra cost to STPI.

E. System & Link redundancy:

The equipment installed for Primary Path / secondary path has to extend end-to-end Lastmile connectivity and it should have 1:1 redundancy. Also, the Optic fibre / copper media should have another redundant or alternate path for end-to-end Lastmile connectivity requirement. In case any failure of primary path the system has to route the link to the Secondary path without impacting the data traffic. Once the primary path is normalised, the link on the secondary path has to be automatically reverted back to the primary path.

F. Operations Support Requirements:

a. Remote monitoring capability

STPI seeks technical help for Remote Support during normal business hours as well as offhours emergency support for all Optic fiber/copper site locations. These services would include:

- Power On/Off
- Eyes on Equipment (with telephone support from STPI technical team)
- Connect / disconnect status of Optical fibers
- Cross Connects System

b. Continuing availability of spares:

Empanelled Service provider should have backup spare in proper ratio to maintain the consistent availability of connectivity.

c. Required in-service dates:

Empanelled Service provider should plan for preventive in-service activity to maintain the connectivity consistent at all times.

d. Standard/Emergency maintenance practices:

Prior intimation / permission of STPI official would be required in case of Standard / Emergency maintenance.

e. Testing and turn-over practices for new fibre assignments:

Empanelled Service provider should plan for the initial testing, performance analysis and Page $28\ {\rm of}\ 50$



successful implementation of entire fibre\copper connectivity to STPI before commencement of new fibre/copper assignment in existing fibre\copper network.

H. QoS Requirements:

The Quality of Service of the proposed Lastmile services shall be as follows:

The minimum guaranteed link availability shall be **99.5%** while the other service parameters like Latency, shall be measured at a maximum of 90% loading only.

a. Service Availability: -

The Empanelled Service provider shall guarantee that the services will be available for 99.5% or better, of time averaged over a period of one month with reference to each parameter namely Throughput, Round Trip delay. Non Conformance to the limits of any of the parameters shall be counted towards service unavailability.

The distinction between Service Availability and Service Outage shall be made as per the parameters in the Table-A below:

If any of the above service parameters varies intermittently for periods less than 30 minutes between acceptable to unacceptable & if such behavior is observed continuously for one hour then the service would be considered to be unavailable for one hour. The duration for which SLA performance parameters are not met will be taken towards service outage and credit calculations.

b. Service Degradation / Delay in Implementation

During Implementation stage, any delay beyond 4-6 weeks from the date of issue of Work Order, Penalty at the rate of 0.5% per week on the total work order value will be levied subject to maximum of 4% which shall be deducted in the first quarterly bill. If breach or delay is beyond acceptable time, then STPI at its discretion shall terminate the contract and may avail the service from other Empanelled Service providers. The non performing Service provider may not be considered for future requirements of STPI.

In case the service delivered by the Empanelled Service provider do not meet the QoS parameters mentioned above, the Empanelled Service provider is liable to pay penalties for service degradation.

c. SLA Management Process includes the following parameters:

- 1. During Feasibility stage, any delay beyond 1 week from the date of feasibility request by the STPI Centre(s) is considered to be non-adherence to their SLA commitment. This information shall be noted and recorded.
- 2. During Implementation stage, any delay beyond 4-6 weeks from the date of issue of Work Order, Penalty at the rate of 0.5% per week will be levied subject to maximum of 4% which shall be deducted in the first quarterly bill. If breach or delay is beyond acceptable time, then STPI at its discretion shall terminate the contract and avail the service from other Empanelled Service providers. The non performing Service provider may not be considered for future requirements.
- 3. During Operations & Maintenance Stage, for the reasons stated above in clause of O&M stage, the % of link down time is calculated on quarterly basis and the penalties are levied on the empanelled Service provider on Quarterly basis. The penalties levied will be as per Table B above.

I. Uptime

a. The service uptime refers to availability of service provided by Empanelled Service provider right from CPE router to the router/switch port of STPI Centre(s). Failure at any segment of



Lastmile connecting STPI's customer's router/switch to STPI Centre's router/switch is the responsibility of Empanelled Service provider.

- b. The following are exclusions for availability calculations:
- c. Service unavailability due to failure of any of STPI's equipment connected to this link
- d. AC Power supply failure at STPI premises affecting the power supply to Empanelled Service provider's equipment providing the service.
- e. Service unavailability due to physical damage / disturbance to the equipment and / or cables of Empanelled Service provider that was caused by STPI employees. (Empanelled Service provider has to substantiate such claims).
- f. During any instance of service outage, for the purpose of availability calculation, the duration of corresponding trouble ticket shall be considered.

J. Latency:

Latency refers to the average time required for round-trip packet transfers between STPI & its client, the Empanelled Service provider is expected to give end-to-end latency within acceptable limits. However, the maximum latency for Last mile shall not exceed 20ms, while, the maximum latency for Long Distance shall not exceed 50ms.

- a) In case of any deviation from the committed latency to any of the destinations continuously for duration of more than 30 minutes, the service is considered as unavailable. The unavailability period shall be equal to the duration of the corresponding trouble ticket opened and has to be added to the overall unavailability for the month.
- b) If STPI observes high latency, route trace shall be sent and a trouble ticket shall be opened. In case of any dispute, each of the parties should substantiate their claim through recorded trace-routes.

K. Report format

The monthly report shall clearly indicate the following:

- a) Summary of overall uptime for the month
- b) Number of trouble tickets, Incident or Problem details and outage duration if any
- c) Creditable outage calculation and corresponding service/financial credits for the month.

The date of commencement of the SLA would be the date of service acceptance.



- The Empanelled Service provider(s) shall be required to provide comprehensive service support with effect from the date of commencement of services till the end of the Services.
- The technical telephonic support related to services should be available round the clock on 24*7*365 basis. The technical personnel responsible for the maintenance of Lastmile in all respect must have telephone connections and cellular mobile connection for contacting them round the clock. Any change in such details should also be intimated to STPI with sufficient prior notice.
- The vendor may provide access to web-based tools, which will allow monitoring of the real-time performance of the link serviced to STPI.
